

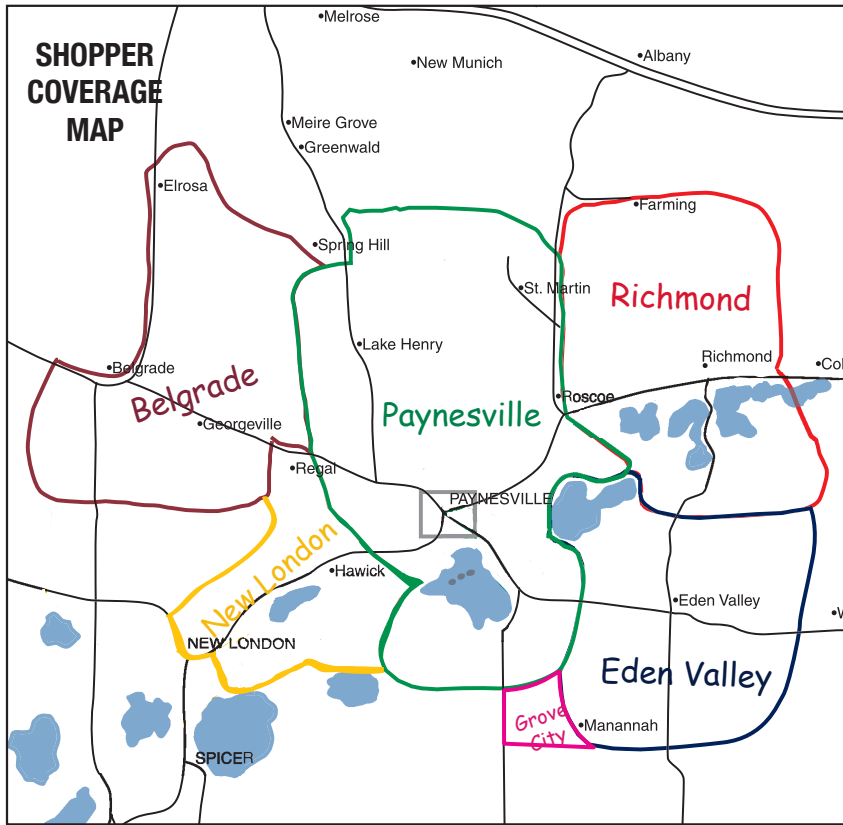
# 2019 Information & Rate Guide

## PUBLICATION INFORMATION

**The Paynesville Press** (1,900) is a weekly, paid circulation newspaper distributed on Wednesday in both print and online. It is a broadsheet product and is mailed second class at the Paynesville Post Office. The Paynesville Press is printed on a web press and is 21 1/4" x 11". Each page is divided into 6 - 1.73" columns.

**The Eden Valley-Watkins Voice** (800) is a weekly, paid circulation newspaper distributed on Wednesday in both print and online. It is a broadsheet product and is mailed second class at the Eden Valley Post Office. The Eden Valley-Watkins Voice is printed on a web press and is 21 1/4" x 11". Each page is divided into 6 - 1.73" columns.

**The Shopper** (6,600) is a free total market coverage publication reaching every home and business in our trade area each Sunday. It is a tabloid-sized product delivered by city carriers and motor carriers. The coverage map for this area is shown below. The Shopper is printed on a web press and is divided into 5 - 1.73" columns.



**The Classy Canary** (36,000) is a tabloid-sized common supplement carried in the Paynesville Press and many other participating paid circulation newspapers. It gives advertisers broad-area coverage. Other participating newspapers are: Alexandria, Glenwood, Wadena, Benson, Morris, Sauk Centre, Elbow Lake, Wheaton, Hoffman, and Long Prairie.
